This privacy policy ("*Policy*") is effective as of September 5, 2023 and applies to its U.S. based websites, and mobile sites that expressly adopt, display, or link to this Privacy Policy. As applicable, this Privacy Policy also applies to information we collect, use and disclose in connection with OHD Parts' pages on social media sites, such as Facebook®, Twitter®, Instagram®, Pinterest®, LinkedIn®, or others. Any use prior to this date may be governed by an earlier version of this policy. Your Consent. By accessing the Site, you expressly consent to OHD Parts' collection, use, disclosure and storage of your personal information and other information received by us as a result of such use in accordance with this Policy, the Terms of Use, your consent, and as permitted or required by applicable law. If you do not agree to the forgoing, you should immediately stop using or accessing the Site. In the event you change your mind at a later date, you may withdraw your consent for us to contact you, for the continued collection, use or disclosure of your information, or modify your contact information, by sending a request with sufficient detail that allows us to properly understand, evaluate, and respond to the email address listed above and indicate on the subject line, "Privacy Compliance." Please also note that the Site may be hosted in countries other than yours, including the United States. By accessing the Site, you expressly consent to the transfer of your information outside of your home country, which may provide for different data protection rules than in your country.

OHD Parts' Collection of Information. OHD Parts' Site does not record your name, mailing address, email address, phone number, or similar information unless you provide it to us. Examples of how you may provide this type of information to OHD Parts is when you respond to a survey, fill out a form, request information, create an account, or connect with us through email, or by phone. When you establish an online account or register on our Site or our we may collect information about your user identification and password. When you purchase products or apply for service with OHD Parts, we may collect commercial information such as credit or debit card number or such information may be collected and processed on our behalf by our vendors; we may also obtain information about you from outside credit reporting agencies to help us with customer authentication and credit-related decisions. We also draw inferences from the information you provide to create a profile about you reflecting your preferences, characteristics, and patterns, When you provide it to us, we may collect sensitive personal information such as such as an individual's social security, driver's license, identification card, or financial account, debit or credit card number. OHD Parts may use the information we have collected to fulfill your requests, administer programs, provide services, train our employees, and for other legitimate business purposes. We may also use the information you provide to send you marketing communications. At any time, you may update and correct your personal information, request that we delete your personally identifiable information, or deactivate your account. This can be done by either logging into your account to make the change or by contacting OHD Parts using one of the methods listed above.

OHD Parts' Site may use location-based services. For example, our Site may allow you to search for a store that sells OHD Parts products. If you access our Site through a mobile device or desktop device and you have enabled location-based services, specific location information may be collected. Security. OHD Parts has implemented reasonable security measures to protect the confidentiality of personal information under our control and appropriately limits access to it. In certain areas of this Site, OHD Parts may use SSL encryption to enhance the security of data transmissions. While OHD Parts strives to protect your personal information, we cannot guarantee that our safeguards will prevent every unauthorized attempt to access, use, or disclose personal information. OHD Parts urges you to take every precaution to protect your personal data when you are on the Internet. Laws and regulations guide us in how to give you notification when certain types of sensitive information are involved in a security breach. We will provide you with notice in accordance with these laws and regulations. If you become aware of a security issue, please contact OHD Parts at the email address listed above.

**Data Retention**. We may retain your information for as long as your account is active; as needed to provide you products or services; as needed for the purposes outlined in this Policy or the purpose outlined in the policy that was in effect at the time the data was collected; as necessary to comply with our legal obligations, resolve disputes, and enforce our agreements; or to the extent required or permitted by law.

**Do Not Track**. Various browsers, including Internet Explorer, Firefox and Safari, currently offer a "do not track" or "DNT" option that relies on a technology that sends a signal to the website a user is visiting about that user's browser DNT preferences. Our system may not respond to DNT requests from some or all browsers.

**Protecting Children's Privacy**. This Site is intended for adults and we do not knowingly collect personal information from children under 13 years of age. If you believe your child has submitted personal information to this Site, please contact us immediately.

Marketing. You agree that by setting up an account, OHD Parts may from time to time send you email advertisements. If OHD Parts sends you email advertisements, we will avoid the use of false or misleading subjects or email addresses. California Consumer Privacy Act Rights ("CCPA"). This section of the Policy supplements the Policy but pertains to the CCPA, and any amendments thereto. This CCPA Section applies solely to individuals who are residents of the State of California as required under the CCPA. California consumers have the right to request that OHD Parts disclose information about our collection and use of your personal information over the preceding 12 months. Once we have verified your request, we will disclose what personal information we have collected about you. We do not sell your personal information in exchange for monetary compensation, but we may disclose your personal information by allowing certain third parties (such as online advertising services) to collect personal information via automated technologies on our websites. California consumers also have a right to request that OHD Parts correct or delete certain personal information that we retain unless we need to retain the personal information in order to do any of the following: provide goods or services to the consumer; detect or resolve issues security or functionality-related issues; comply with the law; conduct research in the public interest; safeguard the right to free speech; or carry out any actions for internal purposes that the consumer might reasonably expect. For data portability requests, we will select a format that is readily useable, and in accordance with the CCPA we will not discriminate against any consumer who chooses to exercise their rights.

California Categories of Personal Data: In the past 12 months, we have collected the following categories of personal information in the manner set forth in this Policy: Identifiers (e.g., name, address, email address, telephone, or mobile number), commercial information (e.g., credit or debit card number or other financial information), internet



and electronic network activity (e.g., browsing time, cookie information, Internet Protocol ("IP") address, or website history), inferences (e.g., profile reflecting a person's preferences, characteristics, trends), and sensitive personal information (social security, driver's license, credit card number). In the past 12 months, we have disclosed personal identifiers, commercial information, and internet and electronic network activity to the following categories of recipients: affiliated companies and subsidiaries; cloud service providers, consultants, data analytics providers, internet service providers, data storage providers, and operating systems and platform providers, and financial institutions. In the past 12 months, we have disclosed inference data to affiliated companies and subsidiaries, consultants, data analytics providers, We do not use or disclose your sensitive personal information for purposes that are not necessary in order to provide our products and services as are reasonably expected by an average consumer requesting those goods and services.

California Resident Access Request. To exercise your right to know, correct, delete, access, or data portability, California residents may submit a verifiable consumer request to OHD Parts brand by either calling 833-314-0167; or emailing privacy@overheaddoor.com. Your request must: (1) indicate on the subject line, "OHDParts.com Privacy Compliance"; (2) provide sufficient information that allows us to reasonably verify you are the person about whom we collected Personal information or an authorized representative; and (3) describe your request with sufficient detail that allows us to properly understand, evaluate, and respond to it. You may also authorize an agent to submit a request on your behalf, so long as you provide the authorized agent written permission to request on your behalf, and your authorized agent additionally is able to verify their identity with us. We reserve the right to deny requests from persons or businesses claiming to be authorized agents that do not submit sufficient proof of their authorization. We will respond to a verifiable request within 45 days.

Consumer Rights as a Nevada Resident. Under Nevada law, residents have many of the same rights as discussed in the California CCPA section above. Nevada residents may also opt out of the sale of certain "covered information" collected by operators of websites or online services. We currently do not sell covered information and do not have plans to do so. In accordance with Nevada law, you may submit to us a verified request instructing us not to sell your covered information. Such requests can be submitted to Support@ohdparts.com.

**Governing Law and Forum**. The laws of the State of Texas govern this Policy. If any provision of this Policy is held to be unenforceable, such provision will be reformed only to the extent necessary to make it enforceable.
